OFFICIAL RULES AND REGULATIONS

THIS CONTEST IS OPEN TO CANADIAN RESIDENTS AND IS GOVERNED BY CANADIAN LAWS.

Standard data rates apply to participants who choose to participate in the Contest via a mobile device. Please contact your service provider for pricing and service plan information before mobile device participation.

- 1. CONTEST PERIOD:** The Contest begins on October 19, 2021 at 12:00:00 a.m. Eastern Daylight Time (“EDT”) and ends on November 30, 2021 at 11:59:59 p.m. Eastern Standard Time (“EST”) (the “Contest Period”). For the purposes of these Official Rules and Regulations (the “Rules”), a day (each, a “Day”) commences at 12:00:00 a.m. EDT or EST as applicable and ends at 11:59:59 p.m. EDT or EST as applicable. Note: At 2:00:00 am on November 7, 2021, the Contest moves to EST until the Contest closing date and time.
- 2. ELIGIBILITY:** The Contest is open to legal Canadian residents who have reached the legal age of majority in their province/territory of residence and reside in Canada at the time of entry and awarding of a prize if applicable, except employees, representatives or agents (and those with whom such persons are domiciled, whether related or not) of Sofina Foods Inc. (the “Sponsor”), its subsidiaries, affiliates, prize suppliers, advertising/promotion agencies and any other individual(s), entity or entities involved in the development, production, implementation, administration or fulfillment of the Contest (collectively, the “Contest Parties”). Groups, clubs, organizations, businesses and commercial/non-commercial entities cannot participate.
- 3. HOW TO ENTER: NO PURCHASE NECESSARY.** To enter: visit www.sharemastrocontests.com/ (the “Website”); click on the Contest button and: (i) complete the Official Contest Entry Form with all required information (your full legal name; telephone number; province; postal code; and email address); and (ii) signify your agreement that you have reached the age of majority in your province/territory of residence at the time of entry and that you have read and agree to be legally bound by the terms and conditions of these Rules (the “Entry Form”). **Optional:** Check the box to indicate that you would like to sign up and start receiving news about products; contest and coupons from the Sponsor. (**IMPORTANT NOTE: It is not necessary to opt-in to receive promotional communications from the Sponsor, and you can opt-out of receiving promotional communications from the Sponsor at any time without impacting your chances of winning in this Contest**). Once you have fully completed the Entry Form with all required information and have read and agreed to the Rules, follow the on-screen instructions to submit your completed Entry Form (the “Entry”). To be eligible, your Entry must be submitted and received in accordance with these Rules. Upon receipt you will receive a “Thank you for entering” message. The information you provide will only be used for the administration of this Contest unless you opted in to receive future communication from the Sponsor and in accordance with the Sponsor’s privacy policy (see below).
- 4. ENTRY LIMIT: There is a limit of one (1) Entry per person, per Day.** For greater certainty and the avoidance of any doubt, an entrant can only use one (1) email address and all personal information provided must be truthful and accurate. For further certainty and the avoidance of any doubt, an entrant can only use one (1) email address to enter the Contest and such email may only be used by one (1) person regardless of whether the email is shared by two (2) or more people. An entrant may not submit an Entry on behalf of any other person, including without

limitation but for greater certainty, another member of his/her household and/or any other family member who may not reside with an entrant. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) obtain more than one (1) Entry, per Day; and/or (ii) use multiple names, identities, email addresses and/or any automated, macro, script, robotic or other system(s) or program(s) and/or any other means not in keeping with the Sponsor's interpretation of the letter and/or spirit of these Rules to enter or otherwise participate in or to disrupt this Contest; then he/she may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. Your Entry may be rejected if (in the sole and absolute discretion of the Sponsor) the Entry Form is not fully completed with all required information and submitted and received in accordance with these Rules. The Sponsor, Contest Parties, and each of their respective officers, directors, agents, representatives, successors and assigns (collectively, the "**Released Parties**") are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed, incomplete or incompatible Entries and/or other information (all of which is void).

5. **VERIFICATION:** All Entries and entrants are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry, and/or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with the Sponsor's interpretation of the letter and spirit of these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification of the entrant and any or all of his/her Entries in the sole and absolute discretion of the Sponsor. Proof of transmission (post-marks, screenshots or captures etc.) or attempted transmission of a submission or of attempted submission of any communication, does not constitute proof of delivery or receipt by the Contest computers or Sponsor. The sole determinant of the time for the purposes of this Contest will be the official time-keeping device(s) used by the Sponsor.

6. **PRIZES AND APPROXIMATE RETAIL VALUES:** There will be a total of four (4) prize packages (each, a "**Prize**" and collectively, the "**Prizes**") available to be won during the Contest Period.
 - a. **Grand Prize:** There will be one (1) Grand prize package (the "**Grand Prize**") available to be won during the Contest Period, consisting of a trip for two (2) (the Grand Prize winner and his/her guest) to Genoa, Italy. The Grand Prize will be issued as follows: (i) a \$4,000.00 CDN travel voucher from a major travel company as selected by the Sponsor in its sole and absolute discretion; (ii) \$2,500.00 CDN spending money issued in the form of a cheque payable in the winner's name as it appears on his/her entry form; (iii) a \$500.00 CDN gift certificate to be used towards the purchase of a Genoa Walking Tour (Discover Hidden Treasures and Street Food which lasts approximately 6.5 hours). The approximate retail value of all three (3) Grand Prize elements is \$7,000.00 CDN. Alternatively the eligible winner can select a cash alternative of \$6,000.00 CDN in lieu of the three (3) described trip elements. The Grand Prize value was determined based on a departure from Toronto International

airport, for travel departing late October 2022 with booking the trip at least ninety (90) days prior to the preferred departure date in return economy class airfare and staying at a moderate hotel for seven (7) nights in Genoa, Italy. The actual retail value of the Grand Prize may vary depending on the point of departure, fluctuation in airfare costs and availability, travel dates and any other factor that may influence the cost of the trip. If the winner elects to take the trip for two (2) to Genoa, Italy, under no circumstances will the Sponsor cover any additional costs or expenses over and above the defined amounts, nor will the Sponsor issue a cheque for the approximate retail value, if the winner is unwilling to travel after the Grand Prize has been awarded for any reason whatsoever or can't afford to pay for any potential additional costs that may arise while booking his/her trip or while travelling all without liability to the Released Parties.

The Grand Prize winner acknowledges that he/she is responsible for booking his/her own trip and for any other costs over and above the provided amounts including but not limited to having all necessary documentation to permit international travel prior to ticketing and travel (the Grand Prize winner and his/her guest accept full responsibility for obtaining these documents at their sole expense), to and from Italy, including not having any barrier for entry into Italy or re-entry into Canada and adhering to all laws, rules, regulations, and mandates related to, concerning, or arising from COVID-19-related travel restrictions and requirements, and for any additional elements including and not limited to health and travel insurance, complying with COVID-19 testing, vaccination, and/or quarantine requirements, transportation to and from the Canadian International airport, excess baggage fees, items of personal nature, and presenting to the hotel if required a valid major credit card. The Grand Prize winner further acknowledges that no compensation for or extension of the Grand Prize will be provided in the event that the winner and/or his/her guest are required to observe local quarantine requirements during all or any portion of the Grand Prize.

- b. **Secondary Prizes:** There will be three (3) Mastro® Charcuterie Prize Packs (each a "**Secondary Prize**") available to be won during the Contest Period. The travel voucher or gift card is subject to the terms and conditions of the issuer and cannot be exchanged for cash or otherwise. To the fullest extent permitted by applicable law, each confirmed winner understands and acknowledges that he or she may not seek reimbursement or pursue any legal or equitable remedy from neither the Sponsor nor any of the Released Parties should the applicable Prize or any portion thereof fails to be fit for its purpose or is in any way unsatisfactory. For greater certainty and the avoidance of any doubt, by accepting a Prize, each confirmed winner agrees to waive all recourse against the Released Parties if the applicable Prize or any component does not prove satisfactory, either in whole or in part.

7. **WINNER SELECTION PROCESS AND ODDS OF WINNING:** At approximately 2:00 p.m. EST on December 14, 2021 a random draw will be held at 317 Adelaide St W., Toronto, ON M5V 1P9, where four (4) eligible entrants will be randomly selected from among all eligible Entries that were submitted and received in accordance with these Rules during the Contest Period. The first entrant selected will be eligible for the Grand Prize and the next three (3) entrants selected will be eligible for a Secondary Prize. The odds of winning a Prize depend on the number of eligible Entries submitted and received in accordance with these Rules during the Contest Period.
8. **ELIGIBLE WINNER NOTIFICATION AND CONFIRMATION PROCEDURES:** The Sponsor or its designated representative will attempt to contact each eligible winner by email (using the information provided on the Entry Form) within five (5) business days of the Draw Date. The Released Parties will not be responsible for failed attempts to contact an eligible winner. If any eligible winner cannot be contacted within five (5) business days of the Draw Date, or if there is a return of any notification as undeliverable; then he/she may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to the applicable Prize) and the Sponsor reserves the right, in its sole and absolute discretion and time permitting, to randomly select an alternate eligible entrant from among the remaining eligible Entries submitted and received in accordance with these Rules during the Contest Period (in which case the foregoing provisions of this section shall apply to such newly selected eligible winner).

NO ONE IS A WINNER UNLESS AND UNTIL THE SPONSOR OFFICIALLY CONFIRMS HIM/HER AS A WINNER IN ACCORDANCE WITH THESE RULES. ANYONE DEEMED BY THE SPONSOR TO BE IN VIOLATION OF THE SPONSOR'S INTERPRETATION OF THE LETTER AND/OR SPIRIT OF THESE RULES FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF THE SPONSOR AT ANY TIME.
- The Released Parties will not be liable for: (i) any failure of the Website; (ii) any technical malfunction or other problems of any nature whatsoever, including, without limitation, those relating to the telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software; (iii) the failure of any Entry and/or any other information to be received, captured or recorded for any reason whatsoever, including, but not limited to, technical problems or traffic congestion on the internet or at any website; (iv) any injury or damage to an entrant's or any other person's computer or other device related to or resulting from participating in the Contest; (v) anyone being incorrectly and/or mistakenly identified as a winner or eligible winner; and/or (v) any combination of the above.

Any attempt to damage any website or to undermine the legitimate operation of this Contest in any way (as determined by Sponsor in its sole and absolute discretion) may be a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law. The Sponsor, (with the consent of the Régie in Quebec only), reserves the right to cancel, amend or suspend this Contest, or to amend these Rules, in any way without prior notice or obligation,

in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever. Without limiting the generality of the forgoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.

- *For Quebec residents:* Any litigation respecting the conduct or organization of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux for a ruling. Any litigation respecting the awarding of a prize may be submitted to the board only for the purpose of helping the parties reach a settlement.
